

ONLINE PRIVACY POLICY AGREEMENT

This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Anne Wallestad Coaching LLC of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

Use of Information Collected

Anne Wallestad Coaching LLC may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from www.annewallestadcoaching.com
